Meet Steven

Steven James struggled with mental illness his entire life, and by age 51 he was living with his parents because he could not maintain an apartment on his own, or care for himself.

Unfortunately, as Steven's parents aged they were no longer able to support him. After a long struggle seeking appropriate help, his parents finally found BCHS, and they were able to get Steven admitted to our Scattered-Site Apartment Program.

Steven moved into a 3-bedroom apartment in Crown Heights. At first he was reserved and nervous, but he soon became friendly with his roommates, finding they had much in common as they shared hobbies and life experiences. Thanks to his BCHS Case Manager (CM) and a psychiatrist, he was able to find the right medication to help with his mental illness, and his CM began working to teach Steven "life skills" - how to shop, prepare meals, and make a budget.

Steven soon gained confidence, and with support from his CM, identified additional goals including finishing his GED and getting a job.

After further vocational training and coaching, Steven saw an ad about being a school bus driver, and though hesitant, he mustered up the courage to call. Steven went on a number of successful interviews with the company and was subsequently hired as a trainee - we are happy to report that Steven eventually got his certification, and since 2018, he has picked up his school bus at 7am each M-F, and driven children throughout Queens to school with the help of his trusted bus matron.

Steven continues to maintain a strong relationship with his family, and visits his mother every other week.

His Case Manager explains:

"During his time at BCHS, Steven has grown more confident, assertive, and responsible. It is wonderful to see!"

COVID-19 Update

Since March of 2020 BCHS' dedicated team has responded to the COVID-19 pandemic with 24/7 compassion and care, ensuring the safety and well-being of our vulnerable residents.

Thanks to our team's efforts, fewer than 3% of our residents have tested positive for the virus since the start of the pandemic, well below the Citywide and national infection rates.

And our efforts continue to evolve as the nature of the crisis shifts. A multi-faceted campaign resulted in all of our staff and the majority of our supportive housing residents receiving their Covid-19 vaccines; rapid testing kits are regularly distributed, as are high quality KN95 masks; and as many activities and services as possible are delivered outdoors, or in large rooms with good ventilation and plenty of space.

We have also incorporated lessons learned – virtual service options and remote programming now complement our in-person operations, and we have automated many more of our administrative functions, achieving greater efficiency.

We are happy to say that this summer also has felt a little closer to normal – we regularly held our in-person therapeutic art and horticultural groups, along with having trips, movie and pizza nights, and periodic summer BBQs. These activities not only represented a fun respite but also provided opportunities for our formerly homeless residents to further develop their socialization skills and deepen important relationships with their peers.

BCHS will remain diligent and flexible, pivoting as necessary no matter what the next phase of the pandemic brings, committed as always to ensuring that our residents remain healthy and thrive.



Program Highlight: Scattered-Site



BCHS opened one of the first scattered-site apartment programs in the country in the early 1980s. Through this model, BCHS rents apartment units in private residential buildings in the community – BCHS holds the lease, and places individuals with mental health diagnoses who may have been homeless into these apartments.

The scattered-site model is an integral part of the supportive housing continuum, as it offers the ability to make safe and attractive housing units available for formerly homeless individuals, without having to wait many years for a new supportive housing building to be constructed.

Residents of BCHS' Scattered-Site Apartment Program receive individualized care from Case Managers, including home visits, and attend support groups and activities that help them socialize and communicate effectively with each other. Learning to live with roommates, building healthy conflict resolution capabilities, and developing daily living skills like cleaning, cooking, and medication management, helps our residents gain the independence they need.

Our Scattered-Site program offers both permanent and transitional housing, and each year more than 95% of our residents successfully maintain their housing with BCHS or move on to even greater independence in the community.

Staff Spotlight: Albertha Roderick



Ms. Albertha Roderick started working for BCHS in 1984, only 6 years after the agency was founded. Ms. Roderick helped make it possible for one of our first clients to move from our scattered-site housing program into permanent housing in the community.

“One of my favorite memories which I'll never forget is my first move out. That was one of my most pleasant, most rewarding experiences. I helped her move to an affordable housing property specifically for seniors,” she said.
